Bear Market Coin (BMC) is a community-driven stability coin built on the Solana blockchain, engineered to thrive in volatile crypto markets. Our mission is to empower users with a resilient, transparent, and rewarding token that blends innovative stability mechanisms, staking opportunities, and decentralized governance. BMC is not just a coin—it's a movement to conquer bear markets with strength, trust, and unity.

Crypto markets are a wild ride, with bear markets challenging even the toughest investors. BMC stands out by offering:

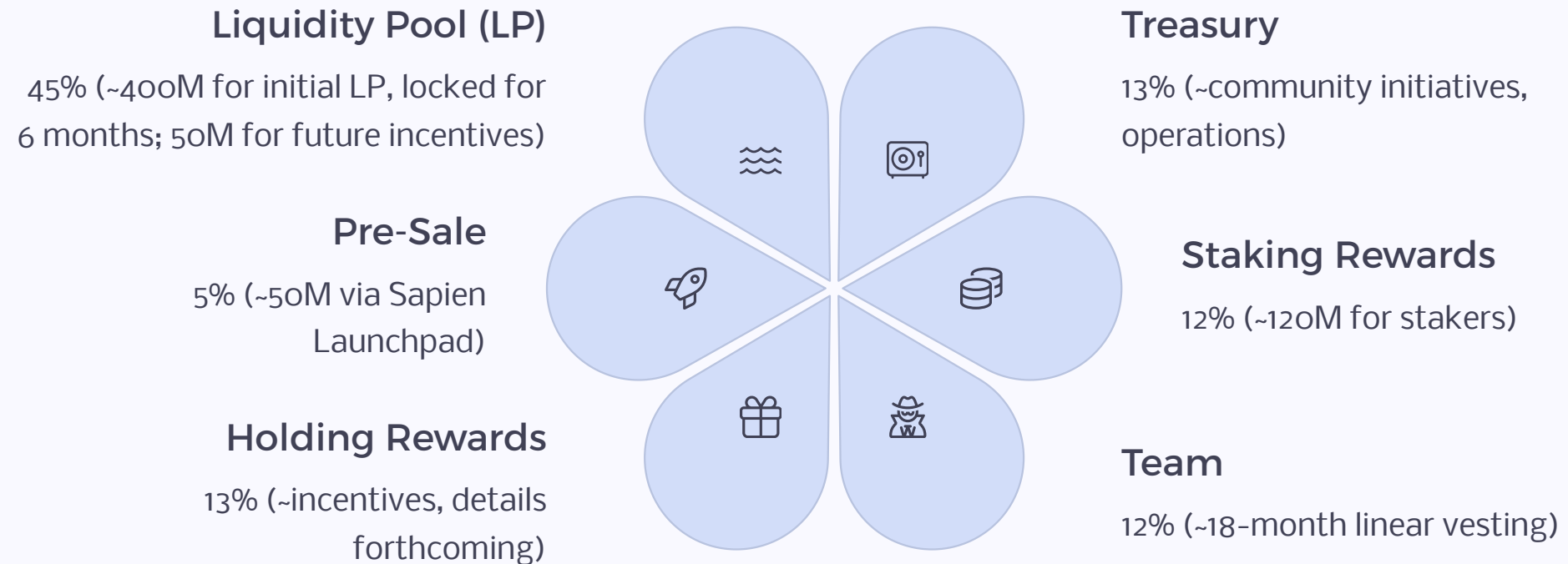
- **Stability:** Smart mechanisms to maintain value during market downturns.

- **Charity:** A dedicated portion of transaction taxes supports vetted charitable causes, voted on by the community.

Transaction Taxes

\$BMC implements dynamic taxes to bolster liquidity, stability, and social impact:

Neutral/Bear Mode (Default)

- Buy Tax: 3% (1% Treasury, 1% LP, 1% Charity)
- Sell Tax: 4% (1.5% Treasury, 1.5% LP, 0.5% Burned, 0.5% Dev/Marketing)

Bull Mode

Triggered by a +10% BTC price increase over 14 days:

- Buy Tax: 3% (1% Treasury, 1% LP, 1% Charity)
- Sell Tax: 3% (1% Treasury, 1% LP, 0.5% Burned, 0.5% Bear Vault)

Note: Wallet-to-wallet transfers are tax-free, ensuring user flexibility.

Core Features

Staking

Stake \$BMC to earn rewards from a 120M \$BMC pool (~1% monthly distribution). Choose lock-up periods of 30, 60, or 90 days, with longer locks potentially offering higher yields. Staking rewards incentivize long-term commitment and community growth.

DAO Governance & Stability

DAO Governance

\$BMC holders govern the project through a token-weighted DAO, voting on:

- Treasury expenditures (>5% proposals).
- Protocol upgrades and parameter adjustments.
- Annual charity fund allocations, with vetted projects selected by the core team and approved by community vote.

Stability Mechanisms

BMC employs innovative strategies to maintain value, including dynamic transaction taxes and community-driven initiatives, ensuring resilience in volatile markets.

NFT Integration

A limited Metaplex Core NFT collection will offer staking multipliers, boosting rewards for dedicated holders and adding exclusivity to the BMC ecosystem.

Charity Commitment

A portion of transaction taxes (1% per buy/sell) funds a charity wallet, distributed annually to community-voted, vetted charitable projects, reinforcing BMC's ethos of social impact.

Technology & Pre-Sale

Technology Stack

- Blockchain: Solana (fast, low-cost, secure).
- Smart Contracts: Developed in Rust with Anchor, audited by SolidProof (~95% test coverage).
- Web App: Vue.js 3/Nuxt.js frontend with Tailwind styling, supporting wallet integration (~Phantom, Solflare, Backpack).
- Infrastructure: Hosted on Hetzner Cloud, secured with Cloudflare CDN/WAF for scalability and DDoS protection.

Pre-Sale Details

- Platform: Sapien Launchpad.
- Allocation: 50M \$BMC (~5% of supply).
- Price: €0.005 per \$BMC (~or stablecoin equivalent).
- Proceeds: 100% to the initial liquidity pool, locked for 6 months to ensure market stability.

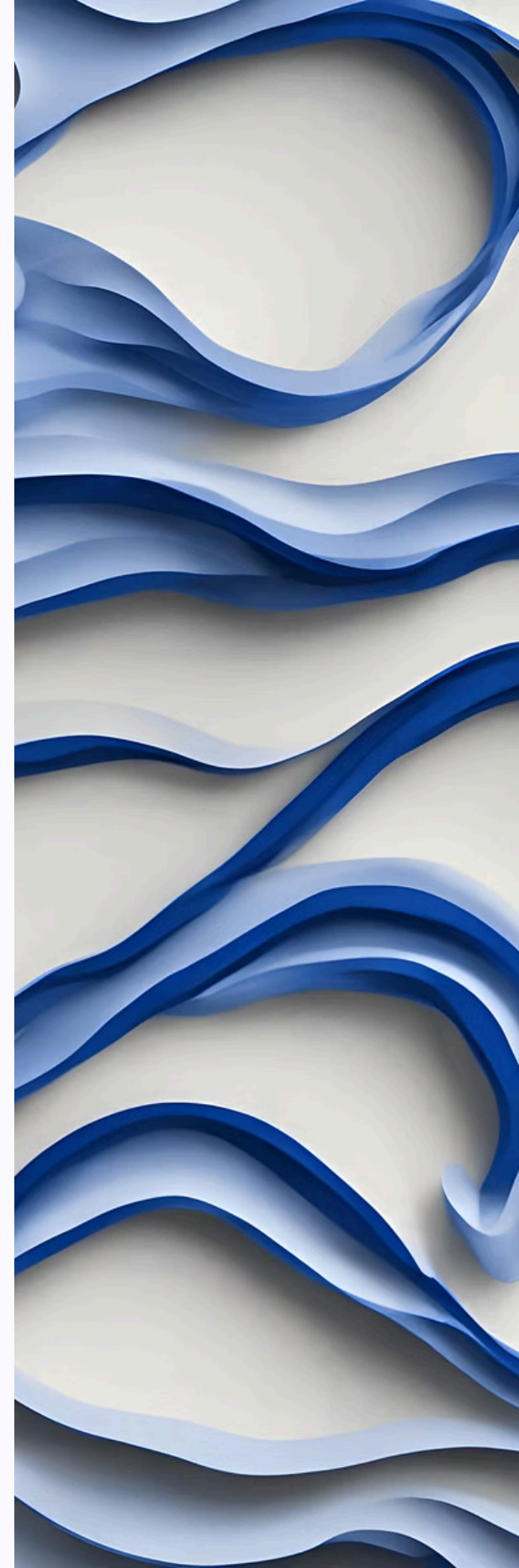
Smart contracts audited by SolidProof, web app OWASP-compliant, infrastructure protected by Cloudflare WAF.
