### Executive Summary

#### Next-Generation Utility Token

Bear Market Coin (\$BMC) is a next-generation utility token built on the Solana blockchain, purposefully engineered for market downturns. In a space dominated by hype and speculation, BMC offers real mechanics, transparent logic, and tokenomics designed to reward resilience over noise.

#### Innovative Mechanisms

BMC uses innovative tax logic, automated market-response mechanisms, DAO governance, and on-chain staking to ensure longterm sustainability and real value creation.

#### Transparent Approach

No venture capital. No shortcuts. No minting post-deployment.

This is not a token made for hype cycles. This is a token built for bear markets.



### Problem Statement

#### Current Market Challenges

- Volatility destroys trust. Most tokens collapse during bear markets due to overhyped tokenomics and weak liquidity strategies.
- Liquidity dries up. Presale funds often vanish, leaving users exposed and tokens illiquid.
- Utility is missing. Projects lack real use cases, relying on speculative momentum that fades quickly.

#### **Governance Issues**

- Whales dominate markets. Centralized token control enables market manipulation and exit scams.
- Communities lack governance. Most holders have no say in how a project evolves or allocates resources.

#### The BMC Solution

\$BMC addresses these fundamental problems with a resilient design.

### The BMC Solution

\$BMC is designed to thrive when others break. Core innovations include:



#### Adaptive Tax Logic

- Transfer Hook powered by SPL Token-2022
- Taxes vary based on BTC trends via Pyth Oracle
- Buy/Sell taxed dynamically to fund treasury, LP, burn, charity

#### 100 % Presale Liquidity

- No token unlocks, no team dilution
- LP tokens locked for 6 months via Streamflow

### Bear Market Automation

- Auto-buyback & burn on price drops (≥ 30 %)
- Bear Accumulation Strategy: DCA into BTC/SOL/USDC
- Spring Awakening Strategy: Capital reallocation in bull trends



#### **Utility & Functionality**

- On-chain staking with lock-up periods
- NFT multiplier logic (Metaplex Core NFTs)
- DAO-controlled treasury + charity wallet voting

### Token Utility

\$BMC is not just a tradable asset – it's a working mechanism:

#### Transfer Tax Logic

Powers ecosystem funding, charity, LP growth, and deflation

#### Staking

Rewards long-term holders with proportional yield

#### NFT Boosts

Allow exclusive staking bonuses

#### DAO Governance

Empowers the community to manage treasury and upgrades

#### **Charity Integration**

Channels a portion of every trade into global impact

- NFTs: Metaplex Core
- Frontend: Vue.js 3 + Nuxt.js •
- Backend: Nuxt API / Node.js •
- Wallets: Phantom, Solflare, Backpack (via @solana/wallet-adapter)
- Infrastructure: Hetzner Cloud + Cloudflare (CDN, DNS, WAF)
- Deployment: CI/CD pipeline via GitHub Actions •



#### Smart Contract Features

• Transfer Hook

Dynamic tax system (Buy/Sell)

### • Mode Switching

Auto switch between Bear/Bull logic based on BTC trend

#### Buyback & Burn

Treasury-triggered events with cooldowns

#### **Anti-Whale Protection**

Max wallet cap: Starts at 0.5 %, rises to 1 % Max daily sell: 0.5 % of supply per wallet

#### DAO Voting

Proposal threshold, quorum, approval logic

#### • Charity Wallet Governance

Community decides on donations annually

#### • Staking Contract

Lock periods (30/60/90 days) with weighted yield

#### • NFT Integration

Boost via limited Metaplex NFT collection

- Audit Scope: Smart contracts, backend components

#### Standards Followed

- SPL/Anchor security best practices
- SWC Registry for smart contract flaws
- OWASP Top 10 for web security

#### **Additional Measures**

- WAF via Cloudflare
- 2FA for all admin access
- CI/CD integration with automated testing
- Audit Requirement: No Critical/High vulnerabilities before Mainnet



#### DAO Governance

Framework: SPL Governance / Realms or Squads Token-Weighted Voting (held or staked BMC)

#### Scope of Authority

- Treasury allocations >5 %
- Contract upgrades
- Key parameter adjustments (e.g., tax rates)
- Annual charity distribution decisions

#### **Voting Parameters**

- Proposal threshold
- 7-day voting window
- Quorum: 5 % of circulating supply
- Approval: Simple or supermajority (>50-66 %)
